Subject to the reporting persons's continued employment with the Issuer, the units vest and convert into shares of common stock (on a 1-for-1 basis) in four (4) equal annual installments beginning on 11/10/2014.
- Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the issuer.
- The original restricted stock unit grant was for 3,000 restricted stock units on 11/12/2012. Subject to the reporting persons's continued employment with the Issuer, the units vest and convert into shares of common stock (on a 1-for-1 basis) in four (4) equal annual installments beginning on 11/10/2013.
- The original restricted stock unit grant was for 1,500 restricted stock units on 11/10/2011. Subject to the reporting persons's continued employment with the Issuer, the units vest and convert into shares of common stock (on a 1-for-1 basis) in four (4) equal annual installments beginning on 11/10/2012.
