Explanation of Responses:

- The number of shares withheld by the Issuer to satisfy the tax withholding obligation of the Reporting Person was inadvertently reported on the date of the original filing of the Form 4 on 12/15/11 as 1064 shares.
- This number was inadvertently reported on the date of the original filing of the Form 4 on 12/15/11 as 1520 shares.
- The restricted stock unit was granted to Steven Hart, an employee of ViaSat, Inc. Upon vesting the shares were contributed to The Hart Family Trust.
- This number was inadvertently reported on the date of the original filing of the Form 4 on 12/15/11 as 649,516 shares.
- The original restricted stock unit grant was for 10,333 restricted stock units on 11/10/2010. Subject to the Reporting Person's election to defer the receipt of the common stock, the units vest and convert into shares of common stock (on a 1-for-1 basis) at the rate of 1/4 on the 13th month anniversary of the grant date; 1/4 on the second anniversary of the grant date; 1/4 on the third anniversary and 1/4 on the fourth anniversary of the grant date.
- Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the issuer.
