- The original restricted unit grant was for 5,806 restricted stock units on 11/17/2020 Subject to the Reporting Person's continued employment with the Issuer, the units vest and convert into shares of common stock of the Issuer (on a 1-for-1 basis) in four (4) equal annual installments beginning on 11/17/2021.
- The original restricted stock unit grant was for 6,287 restricted stock units on 11/17/2021 Subject to the Reporting Person's continued employment with the Issuer, the units vest and convert into shares of common stock of the Issuer (on a 1-for-1 basis) in four (4) equal annual installments beginning on 11/17/2022.
